Urgent Message to our **xpress BILL PAY** and Paperless Customers

If you are a WaterPro customer, you are ALSO a stockholder in our parent company, Draper Irrigation Company (DIC).

To help ensure that you receive **time-sensitive DIC annual stockholder information in February**, please verify that your "Billing Address" is current (and reflects your mailing address) in **xpress BILL PAY**. Please Note: Because **xpress BILL Pay** is a third-party vendor, WaterPro does not have the right to make changes to **xpress BILL PAY** accounts.

To check your **xpress BILL PAY** "Billing Address", log in to www.xpressbillpay.com and select "View Bill". If the "Billing Address" does not reflect your **current mailing address**, edit it by:

1. Finding your name in the upper right corner
2. Click on name
3. Click Account Settings
4. Lower right corner, click **Edit**
5. Update the bottom two lines to reflect **your** current mailing address
6. **Save**
7. Because **xpress Bill Pay** and WaterPro are separate companies, please provide WaterPro with the same address by calling our office at (801) 571-2232.

REMINDER: If you have a large credit balance on your account, please adjust your autopayment at www.xpressbillpay.com as WaterPro **does not** issue credit checks for accounts with large credit balances unless there are extenuating circumstances.

Nominations Now Open for Board of Directors

Our annual stockholders' meeting will be held Wednesday, March 20, 2024 at 7 p.m. at Draper City Hall, 1020 East Pioneer Road.

Two seats on our Board of Directors will be up for election. If you would like to nominate yourself or someone else for a seat on our board, please visit our website at

www.waterpro.net for instructions. Any nominee must be a Class A stockholder. Submissions are due by January 24, 2024 at 4:00 p.m. If you have questions, please contact our office at 801-571-2232.

Filling out your WaterPro/ Draper Irrigation Company Ballet

Ballots for the upcoming stockholders' meeting will be mailed in February. When filling out your ballot, please write legibly. Indicate what type of share/s of stock you own and the quantity. If WaterPro provides your culinary (drinking) water, you have one share of Class B stock. You have Class A stock if you have a pressurized irrigation (PI) service. If you are unsure of how many shares of stock you own, please leave this information blank. Our office staff will confirm your stock using your name and address, so please include this information on the ballot. When joint tenants hold shares, both should sign the ballot.

Please return your ballot even if you choose not to vote for any of the nominees. This will allow your shares of stock to be represented and give the company the 20% presence it needs to constitute a quorum. Thank you!

Three Types of Class A Stock

- 1. 1K** – Automatically transfers with home sale.
- 2. Subdivision Stock (Sub Stock)** - Automatically transfers with the home sale.
- 3. Personal Stock** – The stockholder/s should have a Stock Confirmation Statement or Stock Certificate; if you do not, please call our office. Upon the sale of a home, stock may be sold back to DIC, transferred to the new homeowner, or transferred to another property requiring shares within our service area.
